### President's Message

A number of years ago I read a story that really has stayed with me over the years. I would like to share this story with you.

### The Goose Story

When you see geese flying along in a V formation, you might consider what science has discovered as to why they fly that way. As each bird flaps its wings, it creates an uplift for the bird immediately following. By flying in V formation the whole flock adds at least 71% greater flying range, than if each bird

flew on its own. People who share a common direction and sense of community can get where they are going more quickly and easily because they are traveling on the thrust of one another. When a goose falls out of formation it suddenly feels the drag and resistance of trying to go it alone and quickly gets back into formation to take advantage of the lifting power of the bird in front. If we have as much sense as a goose we will stay in formation with those who are headed the same way we are. When the head goose gets tired it rotates back in the wing

and another goose files point. It is sensible to take turns doing demanding jobs with people or with geese. Geese honk from behind to encourage those up front to keep up their speed. What do we say when we honk from behind? If we have the sense of a goose, we will stand by each other like that.

As members of SECBA, we need to stay in formation and work together toward common goals in order to strengthen our businesses and our community.
